



**BC/49 GAME CONDITIONS and PRIZE STRUCTURE**

**1. RULES AND REGULATIONS**

BC/49 is governed by the Rules and Regulations Respecting Lotteries and Gaming of British Columbia Lottery Corporation (BCLC) which include limitations of liability and are available from BCLC upon request.

**2. ISSUANCE OF TICKETS**

To participate, a person must select his/her numbers or request a Quick Pick (where all selections are computer generated) and pay \$1.00 for each six-number selection per draw to BCLC's authorized retailer or BCLC where applicable. A ticket, as defined in the Rules and Regulations Respecting Lotteries and Gaming, will then be issued showing: the draw date(s); the 6-number selection(s); the amount wagered; the control number(s); the applicable game(s); and other relevant information. Consecutive draws can be played by marking the desired number of draws on a selection slip or requesting a Quick Pick or selecting on PlayNow and paying the appropriate amount. Combination tickets are available in which the six-number selection on one ticket is valid for both BC/49 and Lotto 6/49 draws on the same date provided the appropriate payment is made according to the selection method.

**3. DRAW**

On each draw date, BCLC will cause six main numbers and one bonus number (being seven different numbers) to be drawn at random from among all numbers from 1 to 49.

**4. WINNING SELECTIONS**

Winning Selections as a result of any draw are determined as follows:

<b>WINNING SELECTION</b>	<b>CONSISTS OF</b>
6/6	the six main numbers
5/6+	any five main numbers and the bonus number
5/6	any five main numbers and one other number not drawn
4/6	any four main numbers and two other numbers not drawn OR any four main numbers, one other number not drawn and the bonus number
3/6	any three main numbers and three other numbers not drawn OR any three main numbers, two other numbers not drawn and the bonus number
2/6+	any two main numbers, the bonus number and three other numbers not drawn

**5. WINNING TICKETS**

Any valid ticket for any draw bearing any Winning Selection of such draw is a Winning Ticket and entitles its holder(s) to claim, for each such Winning Selection, a prize calculated in accordance with Section 6 hereof. Only one prize per Winning Selection may be claimed. If a ticket becomes



a Winning Ticket and is eligible for additional draw(s) following the draw date for which a prize is claimed, then such prize will be paid and an Exchange Ticket will be issued for the remaining eligible draw date(s) and the ticket originally produced will, upon issuance of such Exchange Ticket, become void.

**6. PRIZES**

Prizes are determined as follows:

<b>WINNING</b>	<b>SELECTION PRIZE</b>
6/6	\$2,000,000 Win or Share (1)
5/6+	\$75,000 (2)
5/6	\$750
4/6	\$75
3/6	\$10
2/6+	\$5

(1) "Share" means the prize for that category is divided by the number of Winning Selections in that category.

(2) Subject to a maximum total liability per draw for all Winning Selections in this category of \$450,000. If there are more than six (6) Winning Tickets in the 5/6+ category, each 5/6+ Winning Ticket will receive an equal share of \$450,000.

**7. PRIZE CLAIMS**

Prizes must be accepted as awarded and must be claimed within one year following the draw date in the manner stated on the back of the ticket or for PlayNow prizes, in the manner set forth in the Player Agreement.

**8. CANCELLATION OF TICKET**

A person may only cancel a BC/49 ticket at the authorized retailer where such ticket was issued provided that such ticket is cancelled on the same day the ticket was issued and prior to the time sales for that draw end. Or, for a ticket issued on PlayNow in the manner set forth in the Player Agreement, provided that such ticket is cancelled on the same day the ticket was issued and prior to the time sales for that draw end.

Upon cancellation of a ticket, any other game selections entered on such ticket will also be cancelled. Cancelled tickets are void.

**9. TICKETS**

BCLC reserves the right at all times and in its sole discretion to amend or cancel the number of selection(s) available to be purchased on the same ticket, or the number and types of lottery game(s) available to be purchased on the same ticket; or to change the method by which a ticket is issued to a person.

**10. EFFECTIVE DATE**

These Game Conditions are effective and apply to BC/49 in all respect relating to draws following the June 22, 2005 draw until they are further amended.
