



Qualified Entrant and Entry

- A qualified entrant is a BC resident 19 years of age or older, except BCLC employees, Vancouver Canucks employees, TELUS and Marqui employees associated to this contest, BCLC retailers and their respective employees, as well as family and household members of same residing at the same address.
- Self-excluded PlayNow persons are not eligible to enter. Should an Entrant become a PlayNow self-excluded person during the contest period after he or she has earned a qualified entry, he or she will not be eligible to win any prize.
- An entrant can only win once per each draw date. If an entrant's name is drawn more than once on any draw date, only the original entry will qualify and all subsequent entries for this entrant will be disqualified and another name will be drawn.
- Sports Action Tickets (excluding Sports Action Props) purchased from a Lottery Retailer with control number or ticket ID manually entered online at BCLC.com (manual entry):
 - A qualified entry (Entry) is an original Ticket To The Game Contest (TTTG) entry form only located at and submitted to BCLC through the Internet Website www.bclc.com. The qualified entry must be completed in its entirety including the twenty (20) digit control number or ticket ID found at the bottom of a Sports Action ticket (excluding Sports Action Props) valued at \$5 or more.
 - Each \$5 increment on one (1) Sports Action Ticket (excluding Sports Action Props) ensures one (1) entry into the contest (i.e. One \$5 Sports Action game ticket ensures one (1) contest entry, one \$10 Sports Action game ticket (excluding Sports Action Props) ensures two (2) entries, etc.)
 - An entrant must enter in the value of the ticket purchased.
 - Ticket control numbers can only be submitted for Contest Entry once.
- Sports Action Tickets (excluding Sports Action Props) purchased and automatically entered into the contest online at PlayNow (PlayNow entry):
 - Entries will be submitted automatically if the Sports Action (excluding Sports Action Props) purchase was made online in PlayNow. To be eligible, the PlayNow Sports Action ticket (excluding Sports Action Props) must be valued at \$5 or more.
 - Each \$5 increment on one (1) Sports Action Ticket (excluding Sports Action Props) ensures one (1) entry into the contest (i.e. One \$5 Sports Action game ticket ensures one (1) contest entry, one \$10 Sports Action game ticket ensures two (2) entries, etc.)

Contest Period

- The contest runs from **October 26, 2009** up to 23:59:59 hrs PT on **March 9, 2010**.

Draw

- A draw to select six (6) winners will be made on the applicable Draw Date from all qualified entries received prior to the deadline for each Draw Date.
- Qualified entrants are eligible to win only one (1) prize per each Draw Date.
- Upon an entry being drawn, BCLC will certify that the entrant and the entry are qualified as winners.

Draw Deadline, Game Date, Draw Date

- Qualified entries must be received prior to the Draw Date (see table below) corresponding to the applicable Game Date. Game Dates correspond to the scheduled Vancouver Canucks hockey team **REGULAR SEASON** home games on **December 10, 2009, January 16, 2010 and March 24, 2010**. Draw Dates and Draws

- Three (3) draws will be conducted from Sports Action Tickets (excluding Sports Action Props) purchased from a Lottery Retailer during the contest period with control number or ticket ID manually entered online at BCLC.com (Manual Entry) and from Sports Action Tickets (excluding Sports Action Props) purchased and automatically entered into the contest online at PlayNow (PlayNow Entry).
- Upon an Entry Number being drawn, BCLC will certify and declare that the entrant assigned to that Entry Number is the Winning Entrant if such entry and entrant meets these Conditions.
